### **TITLE OF PRIZE**

The Nagasaki Dr. Nagai Peace Memorial Prize

#### **ORGANIZERS**

Nagasaki Association for Hibakushas' Medical Care (NASHIM)

#### **CANDIDATES**

Individuals and/or organizations that have contributed to the development or improvement of research for the medical treatment of people affected by atomic bombs or radiation exposure and thereby improved the welfare of those affected by radiation, thus further contributing towards the goal of achieving world peace.

#### **SELECTION PROCESS**

Nagasaki Association for Hibakushas' Medical Care shall be accepting nominations of candidates for the above prize from domestic or internationally-based academics or professional individuals, as well as universities, research organizations, embassies, governments and other bodies. The Nagasaki Dr. Nagai Peace Memorial Prize Selection Committee which is composed of academic experts will select preliminary final candidates out of the recommended candidates that they receive. The final winner shall then be selected by the Nagasaki Dr. Nagai Peace Memorial Prize Committee, which is comprised of scholars from related fields.

We will accept only one nomination from each group or individual.

### NOMINATION OF SELF OR OTHERS

Candidates may nominate themselves or may be nominated by others.
